Administrative fee to be paid in Belgium for certain type of LONG STAY visa (more than 90 days):

Applicants **under 18** years old do not pay an extra fee (**free**).

Applicants **of 18 years** old or **above** pay an **administrative fee** in following cases:

(a) the applicant is a beneficiary of the Agreement establishing an Association agreement between EEU and Turkey signed on 12.9.1963: **free**

(b) the person to be joined in Belgium has the refugee status: **free**

(c) the person to be joined in Belgium is eligible for subsidiary protection: **free**

(d) the applicant is over 18 years old, unmarried and handicapped (a medical certificate from a doctor approved by the Embassy indicating that he cannot meet his own needs because of his disability has to be presented): **free**

(e) the applicant is a family member of a foreigner to whom a Schengen member state has issued a long-term resident status, and was part of the household of the long-term resident in that other Member State: **60 €**

(f) the person to be joined in Belgium is a Belgian citizen who has used his right of free movement inside the European Union (Directive 2004/38 /CE): **free**

(g) the applicant has the refugee status or is the family member of a foreigner who has the refugee status: **free**
